Hays County Republican Welcome Center

By call of the Chairman, the Hays County Republican Party Executive Committee met at 7:00 PM on Monday, April 26, 2021, at the Welcome Center located at 6000 West FM 150, Kyle, Texas.

Welcome Meeting was called to order at 7:00 PM by Chairman Bob Parks.

Invocation The invocation was given by Bob Mooney.

Pledges to the United States flag and the Texas flag were led by Mary Clarkson.

Recognition of special guests and elected officials There was no report.

Secretary's Report and Approval of Minutes of 3/29/21 Meeting Mary Clarkson made a motion, seconded by Sandy Clauss, that the minutes of the 3/29/21 meeting be approved as published. Motion passed.

Adoption of the Agenda Mary Pat Paul asked that the Agenda be amended to discuss the nomination of David Hawkins, Chair of Precinct 443. Nancye Britner made a motion to accept the Agenda as amended, which was seconded by Mary Clarkson. Motion passed.

Treasurer's Report Mary Pat Paul presented the Treasurer's Report (copy attached). Mary Clarkson made a motion to accept the report. The motion was seconded by Nancye Britner. Motion passed.

Precinct Chair Selection Committee Report and Possible Action Ken Roberts presented the report of the Selection Committee.

The candidate for Precinct Chair for Precinct 443 David Hawkins presented a short biography. He lives in Belterra, attended Stephen F. Austin, has worked at University of Texas Austin, currently working at Dell Medical School negotiating research grants. He has been married since 2015. He believes in the rule of law, votes in primaries, and has voted straight Republican ticket since Ross Perot.

Bob Mooney made a motion to accept David Hawkins as new precinct chair for Precinct 443. It was seconded by Mary Pat Paul and passed.

Ben Broughton and David Hawkins were sworn in by Judge John Burns.

Chairman Parks and Ken Roberts emphasized that we need to get back to work on party business after our Lincoln-Reagan Dinner. We need to fill all the vacant precinct chair positions. Precinct Chairs need to step up, recruit captains, and build their teams. Precinct Chairs should use our 100-100 list to recruit captains. With the growth of Hays County, 50% of our voters are of unknown party affiliation. Due to the delay in the release of the census and the redistricting efforts, we may not have candidates until September. The primary will probably not be in March as usual, but much later in the year. This will leave little time to campaign before the November election. Chairman Parks is meeting with commissioners and others now to discuss redistricting.

Lincoln-Reagan Dinner Report Mary Pat Paul reported that we have approximately \$166,000 in donations and expenses of approximately \$64,000 at the moment. There was discussion by Vicki Alvord and Chairman Parks about some of the details of the dinner. We are expecting Senator Donna Campbell, Commissioner George P. Bush, Congressman Chip Roy, Congressman Roger Williams, Chairman Allen West, Vice-Chairman Cat Parks, and many local elected officials and dignitaries.

Deputy Voter Registration Training Discussion and Possible Action After the Lincoln-Reagan Dinner, we will set up one or two training sessions for Deputy Voter Registration training.

Chairman Parks will address the lack of attendance of our Sergeant-at-Arms with him.

The classes held by Sandy Clauss will be ending tomorrow night, discussing the problems we are facing and their possible solutions. The HCRP appreciates his work on this project.
