Welcome Vice-Chairman Ken Roberts called the meeting to order at 7 PM. Chairman Bob Parks was not in attendance due to flight delays.

Invocation The invocation was given by Bob Mooney.

Secretary's Report and Approval of the Minutes Secretary Vicki Alvord presented the minutes of the April 26, 2021, meeting for consideration and approval. Bob Mooney made a motion to accept the minutes and Mary Clarkson seconded. The motion passed. The secretary reported thirteen precinct chairmen present, being a quorum.

Adoption of the Agenda Consideration and approval of the agenda, motion by Nancye Britner, seconded by Debi Christensen. Motion passed.

Treasurer's Report Treasurer Mary Pat Paul delivered the treasurer's report (copy attached). A motion to approve was made by Nancye Britner, seconded by Debi Christensen. During discussion, Mary Clarkson asked for clarification of how much it costs to run the Welcome Center. The motion passed.

Finance Committee Report and possible authorization of Finance Committee recommendations

The Finance Committee met on Tuesday, June 22, 2021, to discuss a request from Chairman Bob Parks on a budget for the Name Recognition Program (report attached). The Committee asked for approval of a budget of \$50,000 for expenses for this program to promote name recognition for our County Elected Officials who will be running in the 2022 election. A motion to approve was made by Bob Mooney and seconded by Derek Marshall. During discussion, Nancye Britner stated that quite a bit of money was spent during the last election season for

name recognition and was it a worthwhile expense. Finance Committee Chairman Mary Pat Paul responded that it was definitely worthwhile because it did help the candidates get their names before the public. It is the job of the Party to help candidates be recognized, but not to finance their campaigns. The motion passed.

Consideration to amend organizational meeting minutes dated August 20, 2020 allowing Hays County Republican Party Chairman Robert Parks and appointed Treasurer to have authorization to sign on any bank accounts for the Hays County Republican Party – Discussion and Possible Action

A motion was made by Anna White, seconded by Mary Clarkson as follows:

The new signatories on all bank accounts shall be the elected Chairman and the appointed Treasurer, in this event, Robert K. Parks and Mary Pat Paul, respectively. Only one signature is required on HCRP checks. See Resolution for Signing Authority.

The motion passed.

Vice Chairman's Activity Report Vice Chairman Ken Roberts discussed staffing of the Welcome Center, how to staff and hours that the Center should be open. Suggested times are 11 AM to 1 PM on weekdays and 11 AM to 3 PM weekends.

There are upcoming events as listed. John Carter made a motion, seconded by Mary Pat Paul, to have a budget for each event not to exceed \$3,500. The motion passed.

SREC Report There were no SREC representatives in attendance. Mary Pat Paul reported that Toni Anne Dashiell had a forum with the four candidates to replace Allen West as state Chairman, including Chad Wilbanks, David Covey, Bill Burch and Matt Rinaldi. Secretary Vicki Alvord will send a list of the SREC reps with contact information to the Executive Committee so that they can make their preference know to the SREC reps, who will vote on the replacement on July 11th.

Chairman's Closing Remarks In Chairman Park's absence, Vice Chairman Ken Roberts discussed setting a regular meeting date of the last Monday of the month. The ten-day and 48 hour notices would still be sent out, but members could better plan for the future. If there will not be a meeting in any given month, notice will be sent at least ten days in advance.

The delay in releasing Census data will delay all primaries and runoffs, except November 1, 2022 election.

Adjourn Mary Clarkson made a motion, seconded by Bob Mooney, to adjourn. The meeting was adjourned at 7:40 PM.
